## Residents Deplore BNP's Hate Mail

## LRA Counts at County Hall

The County Council elections will be on May 5th. Why does LRA have County Councillors? Chelmsford can seem along way away from the dayto-day concerns of Loughton residents. But the County Council is responsible for key areas that affect us locally - Highways, Environment, Social Services and Education - and has a hand in many others. Overall, it is responsible for over 80% of your Council Tax bill.

LRA councillors are different from councillors who represent national political parties. LRA councillors are elected because they are truly independent and care passionately about what is happening locally. Being an LRA councillor, taking an independent line and trying to look Loughton's interests sometimes satisfying, sometimes frustrating. But we do care, and we do get things done.

What can an LRA County Councillor do? I can take up individual issues and try to sort them out - this means talking to County

officers and other local Councillors on matters such as traffic calming, road crossings, problems with County council services or finding a school governor.

I argue for Loughton when plans are being made for the future - on housing numbers, Green Belt, waste disposal, school term dates and a whole host of other topics. Most of this goes on quietly behind the scenes - we avoid the public yah boo politics that the national parties indulge in.

Another important aspect is to act as an information channel about what's going on and what's planned for the future at County Hall - this helps to make LRA and its District and Town Councillors more effective.

## Sweet Smell of Success

Roding residents are celebrating. It all started in June 2001, when some residents of Avondale and Southern Drives and adjacent roads found their gardens and roads littered with sewage debris following a heavy rainstorm.

After Thames Water did a minimal clear up, Jan Clow invited local councillors, and LRA Chairman at the time, Sheila Shillitto, to her house where 23 residents gathered to tell their stories. Later, over cups of tea in Jan's kitchen, a pressure group was formed,

### Expect a Cleaner Station Approach

The disgusting state of the area around Loughton Station has been a problem ever since the refurbishment of Station Approach and the opening of Sainsbury's. The verges have not been cleaned and the area has become a health hazard.

The problem apparently arose over confusion about responsibility for Station Approach, which involved the District Council, Sainsbury's, London Underground and Metronet.

LRA Councillor Ken Angold-Stephens took up the issue with all the authorities. As a result gates are being cut into the railway fence so Metronet's staff can reach the embankments, which will now be cleaned on a monthly basis.

The District Council has played its part by agreeing to clean all of Station Approach including the verges behind the bus stops even though it has not been officially adopted.

The Campaign to Renew Our Drains – CAMROD, led by Jan Clow and David Hobday. LRA and Councillors offered full support.

The residents and LRA wrote to Thames Water and Ofwat, but received only stalling-action replies. More action followed. CAMROD and LRA and local councillors gathered signatures for a petition, which was sent to the German company that owns Thames Water. Jan and Sheila went door to door and learned that some residents had been complaining to Thames Water about sewage overflow for up to ten years.

Dorothy Paddon, then a District Councillor and member of the Council's Environment Scrutiny Committee, suggested bringing Thames Water before the Council to address the problems. In 2002 Thames Water representatives sat in the Council chamber facing hard questioning, and a large audience of disgruntled residents. They finally instigated a survey of the area, which confirmed that a new pumping station was needed.

The work started in 2003. Now, we are delighted to report a happy ending for a determined group of residents: the new pumping station is built, the area landscaped, and the corner of Avondale Drive and Roding Road is a much pleasanter place to look at and to smell.

Local people had given £1500 towards a fighting fund and over more cups of tea in Jan's kitchen, a cheque was handed over to Haven House Childrens Hospice.

# Too Many Houses for Local Environment

LRA is submitting objections to the draft East of England Regional Plan (2001-2021), which proposes 11,000 new homes in the Epping Forest district. LRA supports the County Council's opposition to the excessive growth proposals of the Plan.

LRA further objects to loss of Green Belt land, and the excessive numbers of new houses proposed locally - of which between 60-70% are unlikely to be 'affordable'. We are raising concerns about pressures on transport, community facilities and on water supply. Pressure on the green belt will increase to accommodate new housing and business sites around Harlow and on North Weald Airfield.

The Plan predicts a large increase in the numbers of jobs available in Essex, arguing that more residents will work nearer home. But if these jobs don't materialise, there will be increased pressure on road and rail transport from those commuting to London.

Congestion and increased air pollution from traffic will threaten our quality of life, and the condition of Epping Forest itself. The Region's own Environmental Report criticises aspects of the plan as 'unsustainable', residents will see a real decline in their quality of life if it is adopted as it stands.

## Objecting to a Planning Proposal

Sometimes people want to object to a planning proposal that affects them or their property. But they don't know how to go about it.

There is a strict time limit on making objections. If you have a planning problem, act quickly, contact your councillors as soon as possible, mobilise local opinion and write your own letter of objection or support to EFDC within the time limit. Don't forget that planning applications are decided on planning grounds, so your objection must be based on planning criteria.

Here is a brief step-by-step guide:

Objectors to applications (as well as promoters) have a limited right to be heard at both the Town Council and the District Council Planning Committees. If you wish to speak at either of the meetings, phone 020 8508 4200 (LTC) and/or 01992 564000 (EFDC) as soon as you hear of the proposal.

Let your Ward Councillor know of the grounds for your concern (see names and contact details on back page of this issue).

Write your own letter of objection to the District Council (EFDC) within the time limit.

If others agree with you, get them to write.

Write to Loughton Town Council – they also scrutinise planning applications and send comments to EFDC.

probably in April-May, where all the agencies will get together to have a big clean-up of the estate, including the removal of abandoned cars, and a cleanup of graffiti by youths serving probation orders.

Despite the BNP's claims to have solved the problem by a "sensible and friendly chat" with the local youths, the police plan should provide a better solution, as long as residents tell the police who is causing the damage and problems, so that prosecutions can follow. A permanent solution will require the concerted efforts of a number of bodies, and LRA will continue to assist in this.

## Leisure Centres – Trust or Private?

Under Government rules, the District Council has to pass over control of Leisure Centres to a private company or a suitable trust, or ratepayers will face higher bills, but after much discussion, the council still has not been able to reach a decision. LRA takes this matter very seriously, and wants to ensure that the centres are not only transferred to the right organisation, but that the public receives an even better service as a result.

The council was given a strictly limited set of options, and only one company's tender complied with the Council's terms. LRA councillors were unconvinced and did not like the lack of choice offered and voted against it. The council was split 50/50 and on a casting vote, the matter was referred back to the Council's Cabinet for reconsideration.

LRA has always favoured the option of a separate trust, which could raise more money for inward investment through tax. We hope this option will now be looked at, and there may be other options. Party political dogma regarding privatisation should not be allowed to exclude fair consideration of other options.

## It's Clear: Bags for Recycling

Clear plastic sacks are used for textiles and cans, which are preferably to be kept in carrier bags and then put in the clear sack. Extra clear plastic sacks for doorstep collection of paper etc can be obtained from the Traps Hill EFDC Information centre, free of charge.

Charges for the collection of bulky items are 1-3 items £22.00, 4-7 £27.00, 7-10 £37.00, 10-15 £45.00.

## Come and hear Town Manager

## Road Repairs Merge

From 1 April, EFDC highways staff transfer to County Council employment, working alongside ECC staff in Great Dunmow and providing a single point of contact for the public.

In addition the county's roads will be split into two categories: "County routes", for which ECC will take decisions, and "local roads", where decision-making will be by EFDC.

Benefits are meant to include a better service to the public, better use of resources, consistent delivery and clearer boundaries of responsibilities.

In the meantime, don't just grouse about highway defects, go to www.essexcc.gov.uk, click on "Report a highway defect" and follow the links - it covers all forms of highway problems.

## Around the Town

#### **Alleyways and Byways**

Emergency services and others find unnamed alleys confusing. In one case, a long-awaited lamppost ended in the wrong pathway! The District Council has agreed that the Town Council may name alleyways in Loughton, subject to some conditions. Local historian and town mayor Chris Pond has prepared a list of suitable names of local significance for consideration.

### Offer to High Road Owners

Owners and tenants of properties in the High Road have been invited to have their land to be incorporated in the enhancement scheme, at no cost to themselves, so the scheme can be as comprehensive as possible.

#### **Borders Lane Crossing**

A puffin crossing is proposed in Borders Lane near its junction with Newmans Lane. LRA County Cllr David Linnell has been assured that the work will be carried out in summer 2005.

#### **Harwater Parking Breach**

The District Council is taking steps against Motorgroup (on the corner of Harwater Drive) who are still breaching their agreed planning condition by using parking spaces intended for flat residents and staff to display vehicles for commercial sale. LRA Town Cllr Roger Pearce and District Cllr Caroline Pond are supporting the residents' rights, and are on the case.

### Dark or Dirty?

If your street needs sweeping or a streetlight is out, report it to the District Council Highways on 01992 564608.

#### **Cemetery Survey**

The Town Council has submitted a planning application to the District Council for the new cemetery in Debden Lane. The next step is for the Environment Agency to get surveys done, to take into account the watercourses near the site.
