Loughton Residents Association is independent and focuses on looking after Loughton.

We have Cllrs on the County & District Councils and hold 21 out of the 22 Loughton Town Council seats.

Demolition of Loughton Library

As we indicated previously, the County Council has now applied to itself for planning permission to demolish Loughton Library on Traps Hill, and replace it with a 5storey block, now with a garage floor. You can read



more at https://tinyurl.com/LoughtonLibraryDemolition, which includes LRA Plans Group's (LRAPG) letter of objection.

Although the consultation ended on 20th October, you can still send your comments by post to the Essex County Council Planning Dept, County Hall, Chelmsford CM1 1QH.

LRAPG acquired the confidential pre-application "Statement of Community Involvement" document relating to the redevelopment of the Library through a Freedom of Information request. The summary demonstrates the majority of residents oppose the development. Over half of the respondents opposed any additional housing, and in particular the size and massing, loss of library space, against the principle of the demolition, parking and impact of the Epping Forest Special Area of Conservation were all registered as areas of objection. Notwithstanding this, only minor changes were made to the scheme before the application was submitted.

It is disappointing that a public authority is ignoring the views of the local community. LRAPG will continue to oppose the development.

LRA Cllr Chris Pond is also seeking to find out how library services will be maintained during the demolition and building period. The County Council to date has only said they "will seek to mitigate the impact of works on users of the building and ensure a continued library offer to the residents of Loughton" without any detail and whether this just means redirecting users to other libraries.

Kings Green War Memorial

The Memorial has undergone restoration recently with a comprehensive clean and repair. The majority of the work has been completed, with the Town Council being impressed by the standard of it. There is still some finishing work to be carried out.



New District Local Plan

The consultation on changes to the Main Modifications of the Local Plan has started, and will run until 9th December.

The process has been long and tortuous. In summary, the Council produced a draft of the Local Plan in 2016, with a lot happening since then (read more on our website at https://tinyurl.com/EFDCNewLocalPlan). The current state of play is that changes to the draft Local Plan (known as Main Modifications) thought necessary by the new Planning Inspector (Mr Bore) have been proposed, and these are now open to review and comment from residents.

After this consultation period, further changes may be made to the Main Modifications, which will then be submitted to the Planning Inspector to determine whether the Local Plan is 'sound' and thus considered to be agreed and final.

LRA Comment: At first sight, LRA is still doubtful whether the new Main Modification on protecting the Epping Forest Special Area of Conservation (SAC) from air pollution from vehicles is strong enough to prevent further damage to the SAC from new housing and other developments nearby.

13, 15, & 15a Alderton Hill

There is a new planning application for demolition of houses at 13, 15 and 15a Alderton Hill, which will be replaced by linked blocks of 89 elderly person's apartments.

LRA Farmers' Markets

The latest position is that we have a firm of market organisers which is interested in starting a weekly market in the High Road, but they have not been able to interest enough traders given recent economic uncertainty, price rises and problems hiring staff.

We will continue to work on starting a market in 2023.

Helping Essex be knife free

A knife bin has been placed outside the Police station on the High Road. The new knife bin joins the County's 14 other knife bins which are funded by Essex Police, the Vulnerable Victims Unit, and the Essex Police, Fire and Crime Commissioner.

Staying fire-safe in the winter

It's also that time of the year to have your boiler serviced and gas appliances checked by a Gas Safe engineer to prevent gas leaks and carbon monoxide poisoning.

You can also contact your energy supplier and request a free gas safety check if you get a means-tested benefit and either:

- Live with a child under five years old
- Live alone or with others and have reached state pension age
- · Live alone or with others and are disabled or chronically ill
- Live with others who have reached state pension age or are disabled, chronically ill or under 18 years old.

Community Warm Places

Warm Places provide a free, safe, warm and comfortable space throughout winter for those who need it. Many of the venues are offering refreshments (with some offering hot food), activities



(with some offering hot food), activities like board games and Wi-Fi.

Locations in Loughton include Debden and Loughton Libraries, St Mary's Church, St Michael's Church, and Trinity Methodist Church. Check the details and opening times at https://tinyurl.com/WarmPlaces and please share them with anyone you know who may struggle to keep warm this winter.

What to do during a power cut

While the energy networks are more reliable than ever, power cuts can sometimes occur. If you have a power cut, and you still have internet connectivity, check for power cuts in the area at https://www.ukpowernetworks.co.uk/powercut and report it, or call 105 (a free call) or 0800 316 3105. What else should you do?

- Switch off all electrical appliances that shouldn't be left unattended, ready for when the power comes back on.
- Leave a low-power light on so you know when the power cut has been fixed.
- Check to see if your neighbours are safe and if they have a power cut too. If they have power, your trip switch may have activated.
- If it's cold, wrap up warm and close internal doors to keep the heat in.
- Contact UK Power Networks, the network operator, to report the power cut on the numbers above.

Text messages are being received containing links to supposedly apply for the government's £400 Energy Bills Support Scheme. If you receive one of these texts, you can be sure it's a scam as all energy support payments will be sent automatically.

Planning & licensing

The LRA Plans Group (LRAPG) looks at all planning and licensing applications in the town and takes action where appropriate. It consults residents and supports, or objects to, individual applications as appropriate. It works entirely separately from LRA's Cllrs on Council planning committees. Where there are residents in flats above licensed premises, for example on the High Road, The Broadway or nearby, the LRAPG objects to late-night licensing applications.

Noise from live music in licensed premises

The Government has removed the conditions imposed on alcohol premises licences regarding the provision of live music between 8am and 11pm.

If a noise nuisance is being caused, residents will have to ask the District Council for a review of the premises' licence; the Council can then impose restrictions if thought appropriate. Other noise legislation, for example in the Environmental Protection Act 1990, will continue to apply (the Live Music Act does not allow licensed premises to cause a noise nuisance).

LRA Comment: this is a retrograde step. It means that if residents are disturbed by noise from licensed premises, they will have to fight for a licence review, with the resulting delays in action, rather than asking the Council to take action immediately to apply existing restrictions. If you are disturbed by noise from licenced premises, the Council will need good evidence before it sets up a review. Please tell the District Council (online or call 01992 564608 during office hours or 01992 564000 at all other times) about the problems, keep a diary of the problems, and ask any neighbours who are also affected to do the same. We have no experience of the other anti-noise provisions, but we suspect they will be equally time-consuming and difficult to apply.

Street parties

Following recent experience, the District Council has made the following changes to its requirements for street parties:

- There will no longer be a £194 fee for community/charitable events.
- Organisers can now apply for approval up to four weeks before the event. Organisers are advised to apply earlier if possible as, if the Council receives any objections, four weeks may not allow sufficient time for the Council to make a decision and they may just have to refuse the application outright.
- The Council will consult Essex Highways. The applicant is responsible for notifying neighbours, businesses, the Town (or Parish) Council and anyone who will be affected by the road closure
- The Council won't ask for risk assessments for events for 500 people or less; it will be up to the organisers to consider the risks involved and document these.
- The Council won't require the organisers to take out public liability insurance (but organisers should consider doing so, for their own protection).

LRA Comment: these changes are pragmatic and very welcome.

16 Station Road

It was very disappointing to see the original Rex Foster house demolished on Station Road, which we considered to be a local building of merit. Being situated outside a conservation area, the District Council could not prevent this from happening. The loss of this asset, however, should not mean the applicant should get away with the significantly larger dwelling which is now proposed.

LRAPG has objected to the excessive bulk of the proposed replacement dwelling, which will sit uncomfortably on its plot and be out of character with this part of Station Road.

Reference EPF/1478/22. The formal consultation period ended 7th October, but you can still comment to the Council.

7a Forest Road

This is an application for two storeys of office accommodation over this terrace of single storey commercial units.

LRAPG has objected to this overpowering development on the grounds the height, bulk and massing will stick out on this part of Forest Road to the visual detriment of Forest Road and this part of Loughton. In townscape terms, the building forms part of a bigger unit with the adjacent shop; it would look ridiculous to extend only half of the site.

LRAPG is also concerned about the poor standard of drawings that are being accepted by the District Council. The plans submitted with this application are wholly inadequate to assess the quality of the design.

Reference EPF/1661/22. The formal consultation period ended 30th August, but you can still comment to the Council.

BT's Proposed Inundation of Loughton and Debden with Street Totems with Large Adverting Panels

A string of planning and advertisement applications have been submitted to the council for enormous street totems in the High Road and The Broadway.

LRA Plans Group (LRAPG) has objected to all the applications. The totems are primarily enormous advertisements with broadband and 5G



thrown in to try to justify them. They are a distraction to motorists and, although thinner than a standard telephone kiosk, are longer in width, considerably higher and block up more of the pavement. They are very tall (almost 10ft) and add to the street clutter. There is very little demand for public phones if any and there are better ways to provide broadband and 5G than sticking them on large advertising pillars. BT has offered some free advertising to the Council and community info in an attempt to sweeten the deal. Some of the sites do not have phone kiosks to replace. Some of these have now been consented.

District Council Cash Office on The Broadway to close

The office will close on 29th November, including the cash desk and the services for housing management.

The Council is offering an AllPay card which allows for cash payments at the Post Office and PayPoints, for residents who prefer to pay in cash. Residents who use the Council's housing management services already have these cards, and Council Tax and business rates customers who have made a payment at the Debden office since it reopened in April 2021 will automatically receive a payment card by post before the office shuts.

Cllr Pond's potholes progress

As a result of LRA's Chris Pond nominating potholes to repair, the following potholes are amongst those scheduled for repair (which may have already been fixed):

- Castell Road 7 patches
- Shelley Grove outside No. 15
- Forest Road outside No. 53 and No. 184
- High Road outside the Methodist Church
- Oakwood Hill outside No. 45 and No. 50, and near the entrance to the Industrial Estate
- Spareleaze Hill multiple ones (6)
- Traps Hill outside the Leisure Centre, opposite the Library and near Eleven Acre Rise
- Tycehurst Hill outside No. 14, No. 68, No. 88 and No. 97. Chris can only report potholes in Loughton Central county division.

District Council Budget

In a report to the District Council Cabinet, there is a prediction of a £1 million overspend in the current financial year, due to reductions in income and higher cost pressures.

In a separate report, for the next financial year the Council is projecting a £4 million deficit. With forecasted expenditure of £19 million and funding of £15 million, this is a significant gap. The Council has been reported as saying that 'services which the council has a statutory requirement to provide would be prioritised, although they would be reviewed to try to make them more cost-efficient'.

The budget situation for all three councils (Town, District and County) is going to be very difficult this year.
